SHAPE can help you standardize the process of school-community partnerships in your district and advance data-driven decision making not only for your district, but also your individual schools if you choose. Finally, SHAPE is not just a data "submission" portal, but instead provides numerous customized reports and resources to support your strategic action planning related to school mental health quality and sustainability.

1. Delegate at least 1 person from your district join SHAPE by answering 12 brief questions online. Your responses will not be shared with the state or other districts, and is only viewed by the CSMH for the purposes of aggregate information for the School Mental Health Census. This step also ensures you can stay up-to-date on SHAPE resources and supports for your district as soon as they are announced. There is no limit to the number of people who "join" from a district or school.

- 2. Assemble a team of 3-8 individuals in your district who work on student mental health and school climate and create **one** district SHAPE registration at <a href="https://theshapesystem.com/register">https://theshapesystem.com/register</a>. This creates an account that the entire team can use.
- 3. Have the team complete following online questionnaires about school mental health in your district:
  - a. School Mental Health Profile, and
  - b. School Mental Health Quality Assessment or Sustainability Assessment

After completing these steps, you will have access to free custom reports about your district's school mental health system and an entire repository of resources to support your school mental health efforts!
